## Requirements

*This information is provided for informational purposes only. The official ordinance will prevail in any discrepancy with these information.*

1. The name and address of the person for which an application is made and the name and address of the owner or owners (if a partnership or corporation, the names and addresses of partners, officers and managers) of the goods to be the object of the sale;
2. The length of time the person has been in business in the City of Twin Falls and the length of time the person has been in business at the address at which the sale is to be held;
3. Whether, and when, any sales enumerated by this Chapter have previously been held by the applicant including the date and location of such sales;
4. A statement explaining the reason for the urgent and expeditious disposal of goods thereby and the manner in which the sale will be conducted;
5. The dates of the period of time within which the sale is to be held;
6. A description of the place where said sale is to be held; and,
7. An inventory describing generally the goods to be offered for sale at the sale. Such inventory shall not include goods ordered in contemplation of conducting a sale regulated hereunder, and any goods purchased within thirty (30) days before the filing of an application hereunder shall be deemed to have been goods ordered in contemplation of a sale regulated by this Chapter.
8. With application a license fee of \$25.00 good for 60 consecutive days, Sundays and holidays excluded.
9. Renew or extend a license for one period of time only, such period to be in addition to the period of time permitted in the original license, and such renewal shall not exceed thirty consecutive days, Sundays and holidays excluded, is \$25.00.
10. Licensee shall submit with the renewal application a revised inventory showing the items listed on the original inventory remaining unsold and not listing any good not included on the original application and inventory.
11. A bond in the sum of \$1,000.00 conditioned upon the observance of this Chapter and for the indemnification of any purchaser at such sale who suffers a loss by reason of misrepresentation.
