- 54-5205(2)(j) - (Rural District/Fire Prevention)**
- 54-5205(2)(k) - (Owner of Property, I do not intend on selling the property during construction or 12 months after completion.)**
- 54-5205(2)(l) - (Owner of Property, I acknowledge that I do not intend on selling the property and if I do it is because I have lived in the property for 12 months prior to the sale.)**
- 54-5205(2)(m) - (Owner or Lessee with Consent of Owner - Perform the Work)**
- 54-5205(2)(n) - (Minor Repairs by or with the help of a Licensed Real Estate Agent)**
- 54-5205(2)(o) - (Forestry or Harvesting Exemption)**
- 54-5205(2)(p) - (Renter or Lessee – with permission of owner)**
- 54-5205(2)(q) - (Chemical Company Exemption)**
- 54-5205(2)(r) - (Modular Home Construction to be installed outside of Idaho, see also IC 39-4301)**

Further, I understand that acting in the capacity of a contractor without a valid exemption is a misdemeanor crime, punishable by a fine not to exceed one thousand dollars (\$1,000) or by imprisonment in the county jail for a term not to exceed six months, or by both such fine and imprisonment, at the discretion of the applicable court.
